Head towards Muizenberg along the M3. Turn right at the T-Junction at the end of the highway. Turn left into Ou Kaapse Weg (M64). Once you are over the mountain you will approach a set of traffic lights. Drive past Longbeach Mall on your right hand side. At the 2nd set of traffic lights, there is a 4-way intersection. Turn right towards Kommetjie. Continue driving until you reach a set of robots with Imhoff Farm on your right hand side. Turn right into Imhoff Farm. Drive past the parking for the farm staff. The road bends to the right, past the Maze. You will see the goat paddocks on your left hand side and the horses on the right. park in this area. NOTE: Whilst the area is relatively secure, please do not leave any valuables visible in your vehicle. We do not accept responsibility for any loss or damage to visitors property. Walk towards the farm gate, using the pedestrian gate on the right hand side. Continue straight up the gravel road until you see the green paintball base.
